

3.1.3 Test Procedures

- 1. The EUT was placed 0.4 meter from the conducting wall of the shielding room, and it was kept at least 80 centimeters from any other grounded conducting surface.
- 2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
- 3. All the support units are connecting to the other LISN.
- 4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- 5. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
- 6. Both sides of AC line were checked for maximum conducted interference.
- 7. The frequency range from 150 kHz to 30 MHz was searched.
- 8. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF Bandwidth = 9kHz) with Maximum Hold Mode. Then measurement is also conducted by Average Detector and Quasi-Peak Detector Function respectively.





3.3 Frequency Stability Measurement





- 6. 



3.6 Antenna Requirements

3.6.1 Standard Applicable

Except for special regulations, the Low-power Radio-frequency Devices must not be equipped with any jacket for installing an antenna with extension cable. An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section.
