





Out-of-band Rejection, Spectrum Plots



Input VS Output, Input Spectrum Plots



Input VS Output, Output Spectrum Plots, UHF Band





Intermodulation Products Spectrum Plots, VHF Band





Intermodulation Products Spectrum Plots, UHF Band



8.7.4 12.5 kHz Signal, Downlink, AGC +3dB





Conducted Emissions Spectrum Plots


8.8.1 30 MHz to 1 GHz, VHF Band Downlink


8.8.2 1 GHz to 10th Harmonic, VHF Band Downlink


8.8.3 30 MHz to 1 GHz, UHF Band Downlink

8.8.4 1 GHz to 10th Harmonic, UHF Band Downlink





