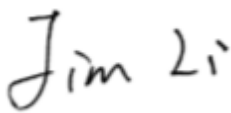
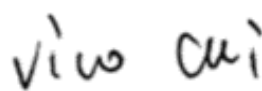

### 5.1 General Description of Applied Standards

KDB447498 D01 General RF Exposure Guidance v06

#### 4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

### 5.2 RF Exposure Evaluation

#### 5.2.1 Limit & Test Method

KDB447498D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$\left[ \frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt{f(\text{GHz})} \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.2.2 Conclusion

Normal use condition for Distance between antenna and body:  $\geq 20\text{cm}$  declared by applicant

The Maximum Conducted Peak Output Power is -3.45 dBm in channel 2.441 GHz;

-3.45 dBm logarithmic terms convert to numeric result is nearly 0.452 mW

$$\left[ \frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt{f(\text{GHz})}$$

$$\text{General RF Exposure} = (0.452 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.441 \text{ GHz}} = 0.141 \quad \textcircled{1};$$

$$\text{SAR requirement: } S = 3.0 \quad \textcircled{2};$$

$\therefore \textcircled{1} < \textcircled{2} \therefore$  the SAR report is not required.
