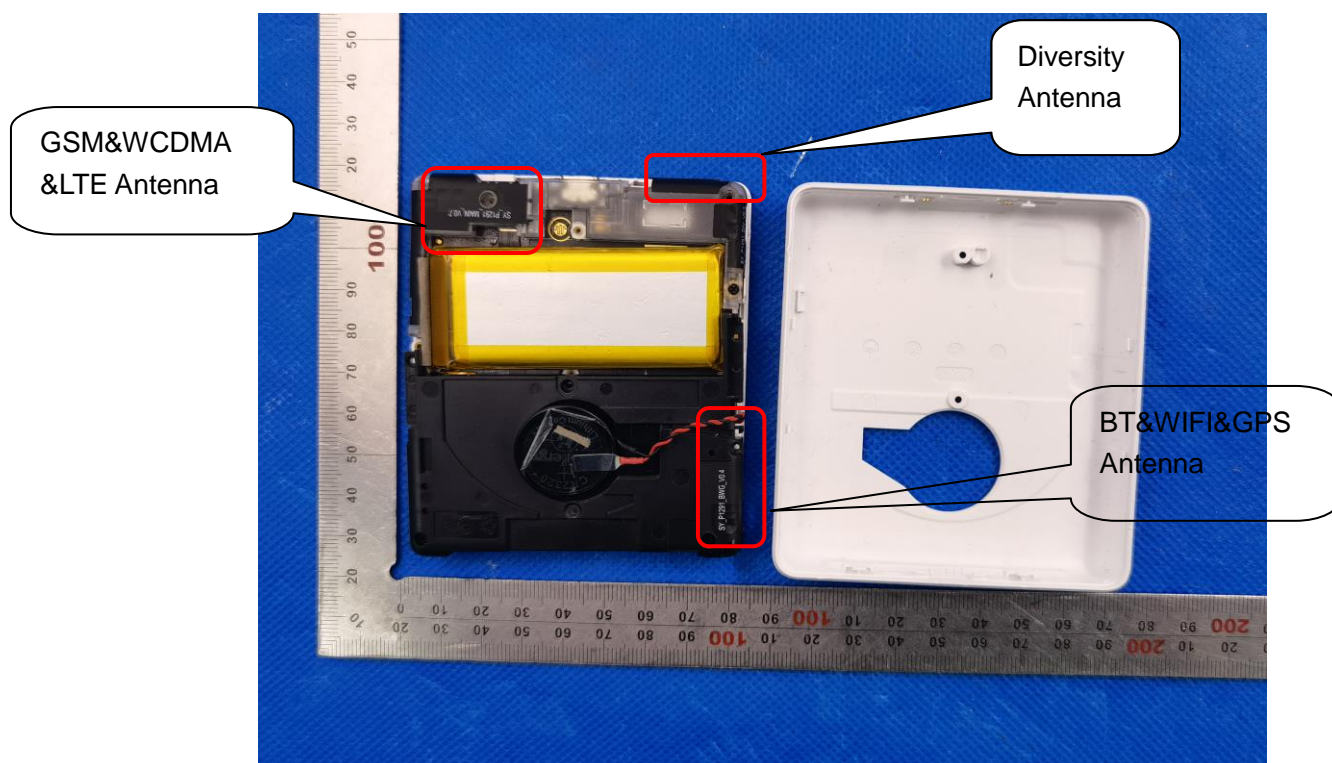
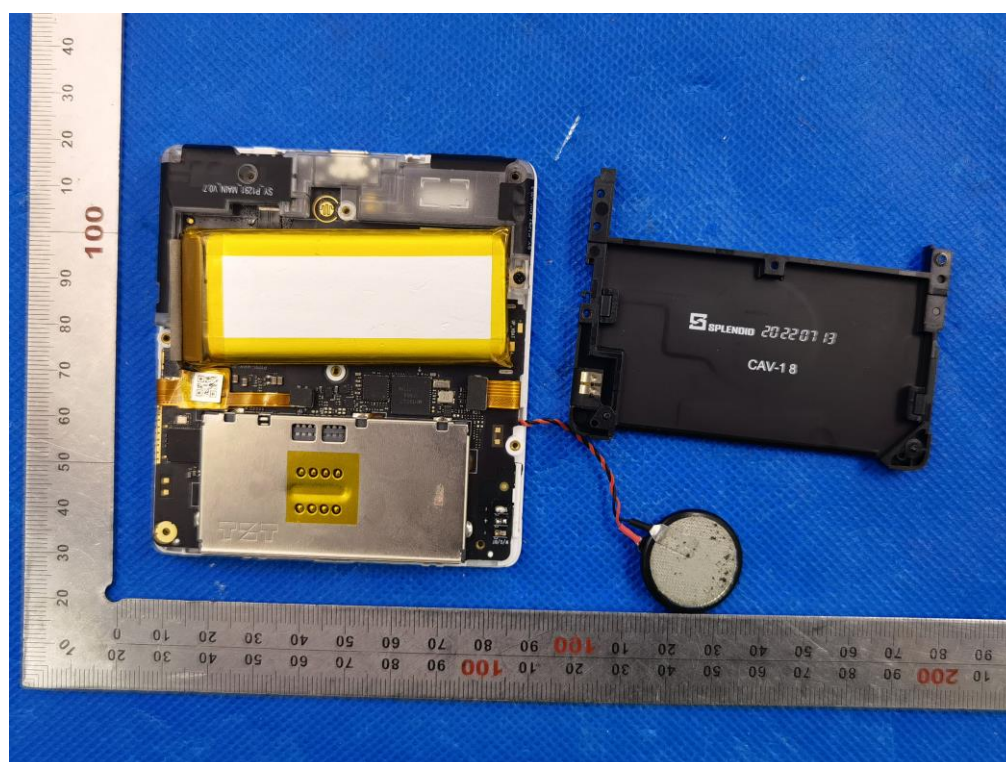

OPEN VIEW OF EUT(FIGURE 2)



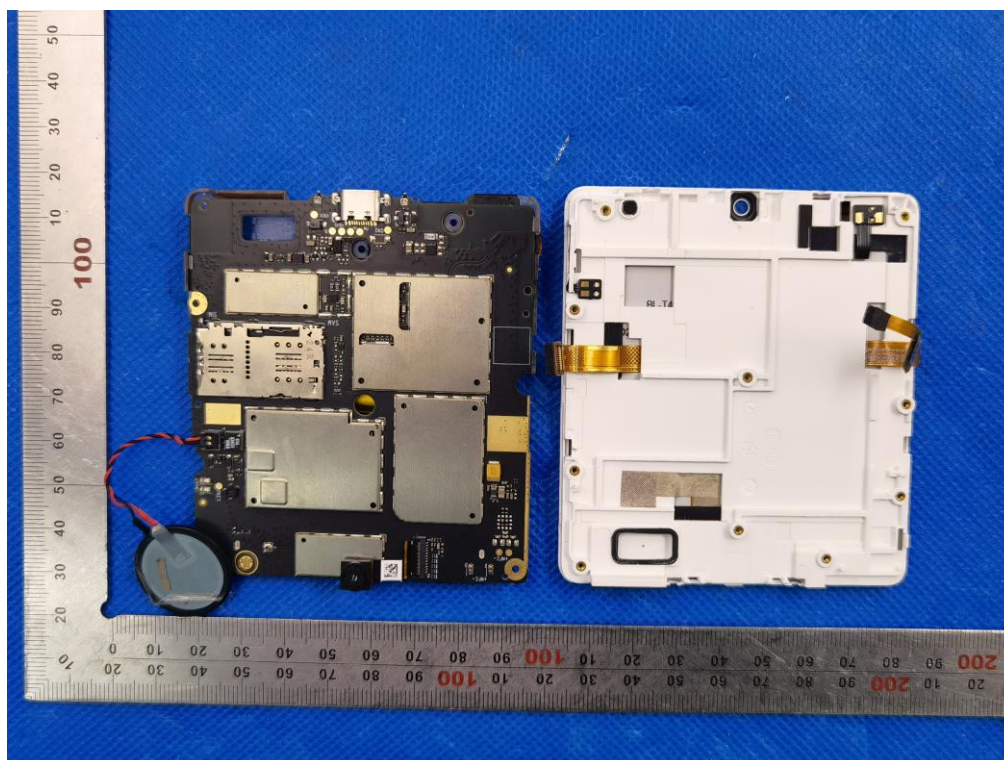

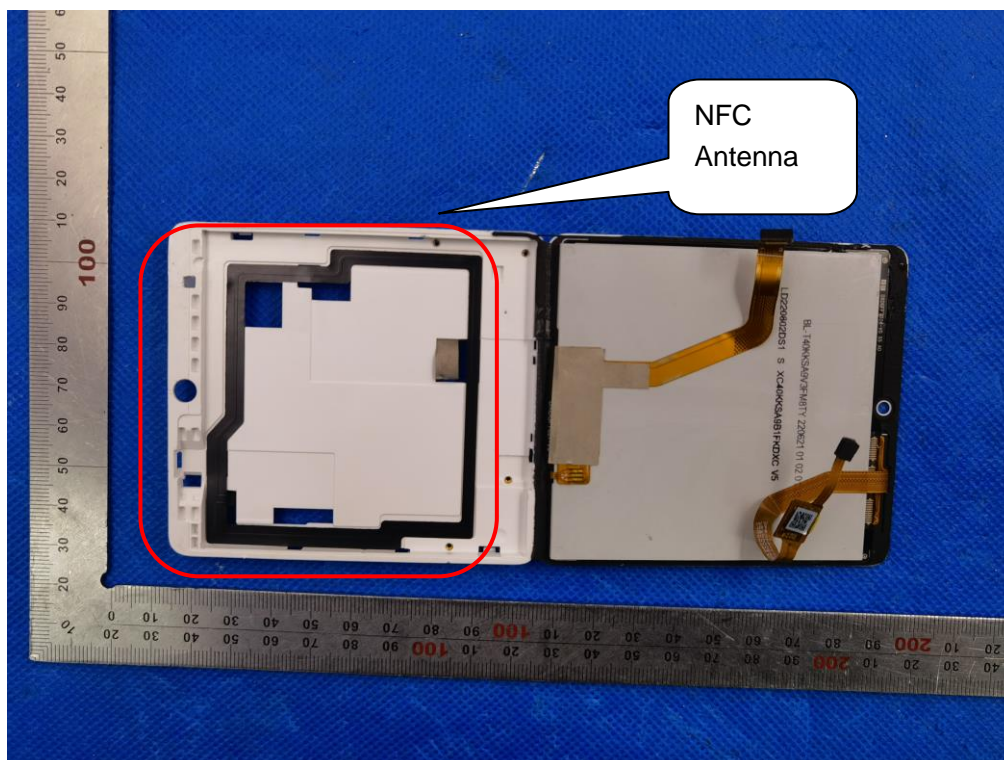

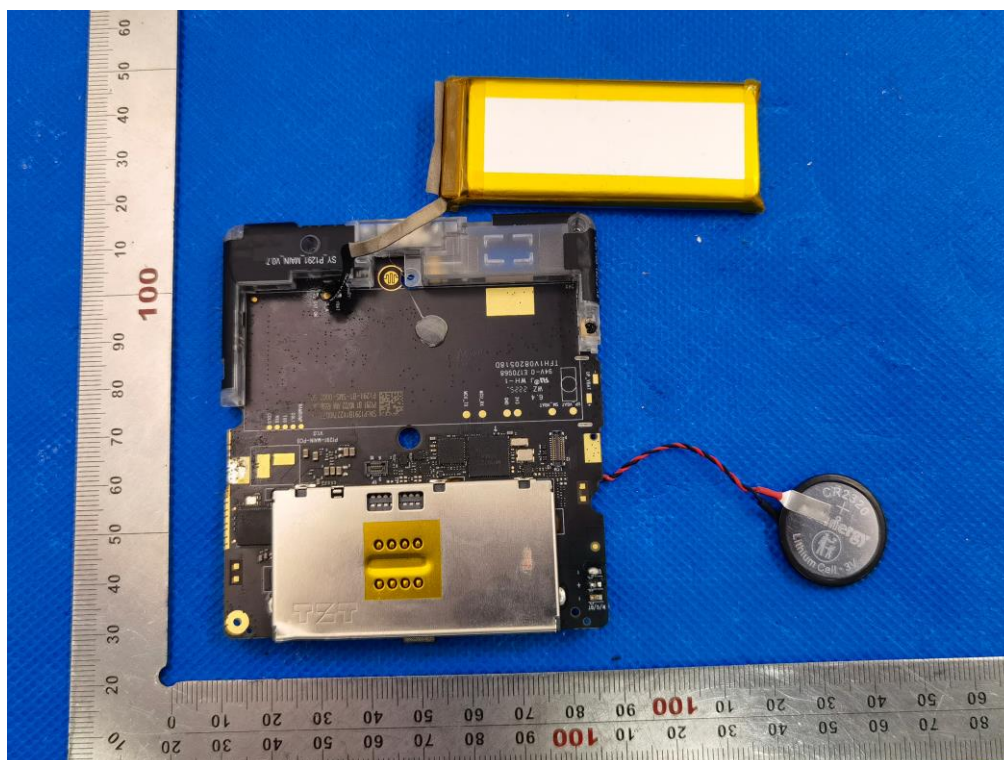

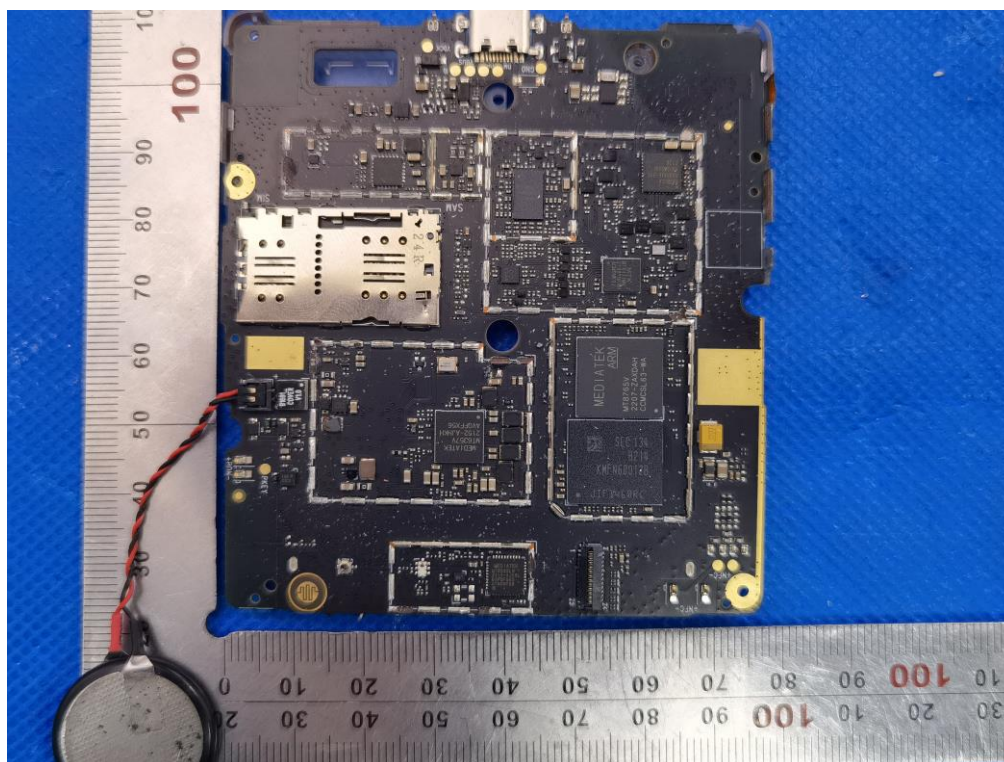

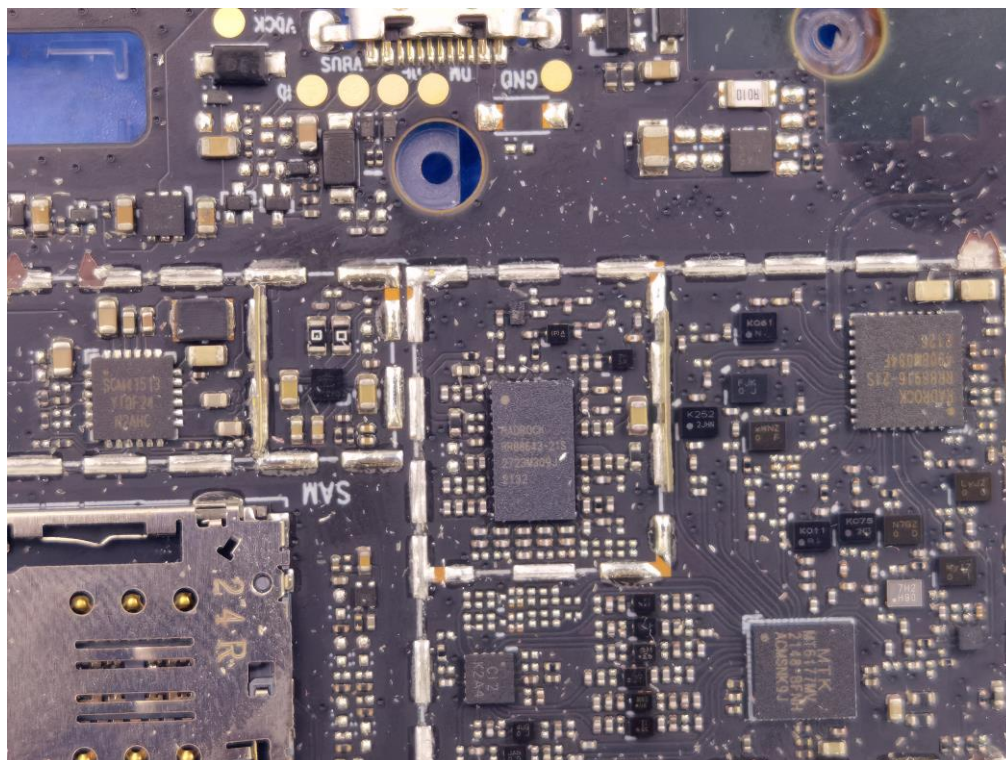

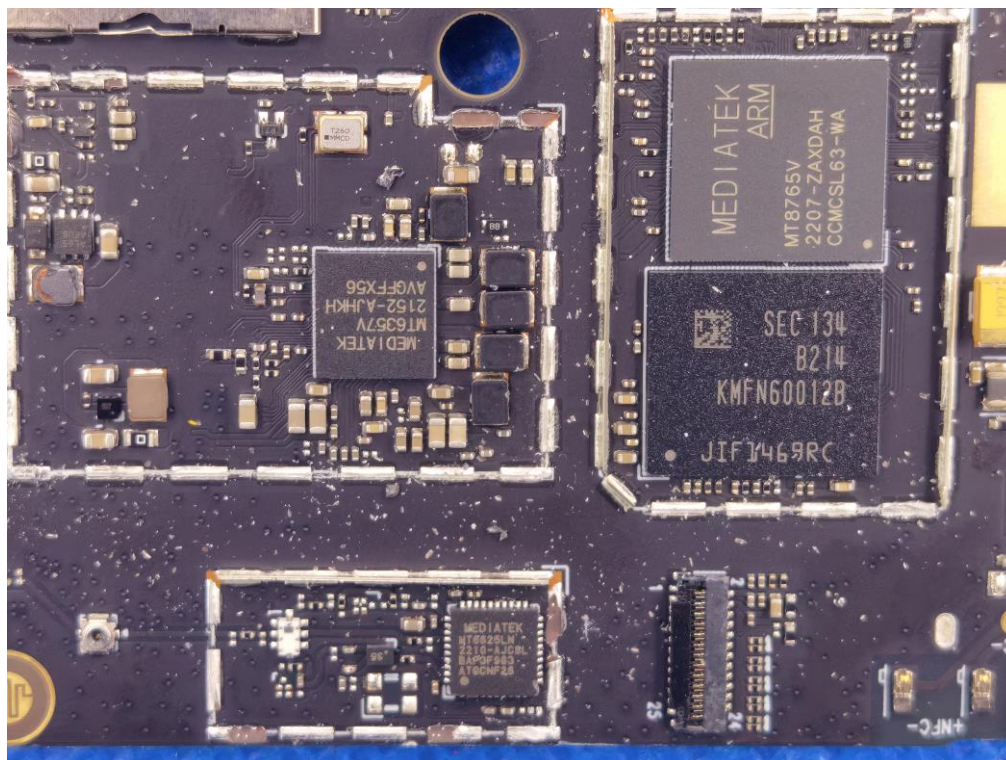
