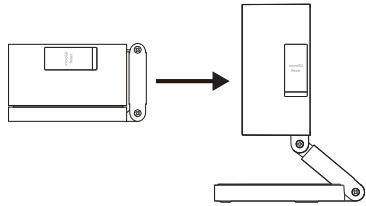


Set Up Your Camera

1. Position your camera's adjustable stand for setup.

Note: Peel off film from the camera before use.



2. Download the **Tapo** app from the App Store or Google Play.

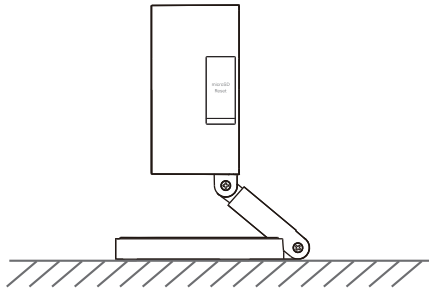


3. Power up the camera. Tap the **+** button in the app and select your model. Follow app instructions to complete setup.

Install Your Camera

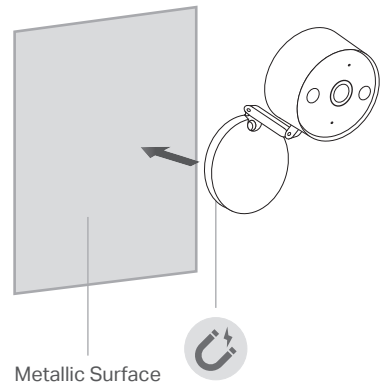
Option 1: Set on a table or shelf

- 1. Place the camera on your desired table or shelf.
- 2. Adjust the stand angle to the notch position in the base for more stability.



Option 2: Mount to metallic surfaces

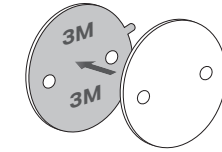
The camera includes a magnet in its base. It allows magnetically attaching to metallic surfaces.



This equipment shall be installed at a height of fewer than 2 meters.

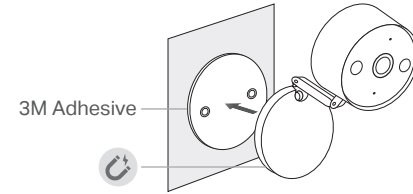
Option 3: Stick to a clean wall

1. Attach the included adhesive to the back of the mental plate.



2. Stick the mental plate with adhesive to a clean wall. Then attach the camera to the plate.

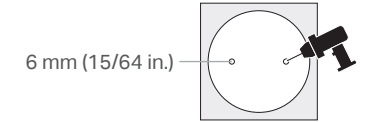
Note: This is applicable with tile, glass, marble, metal, stainless steel, and hard wall surfaces.



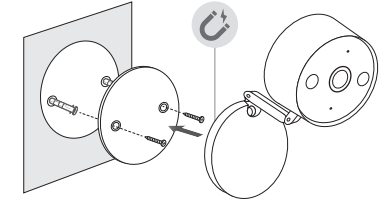
This equipment shall be installed at a height of fewer than 2 meters.

Option 4. Mount to the wall (with or without the mental plate)

1. Stick the mounting template to the desired mounting place. Drill **two** holes according to the template.

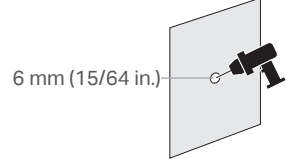


2. Insert two anchors into the holes and use the screws to affix the **mental plate** over the anchors. Then attach the camera to the plate.

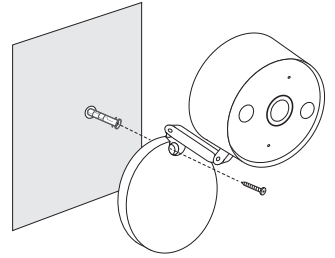


This equipment shall be installed at a height of fewer than 2 meters.

1. Drill **one** hole in the desired mounting place.

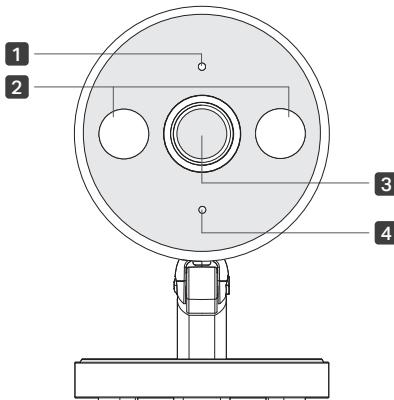


2. Insert one anchor into the hole and use one screw to affix the **camera** over the anchor.



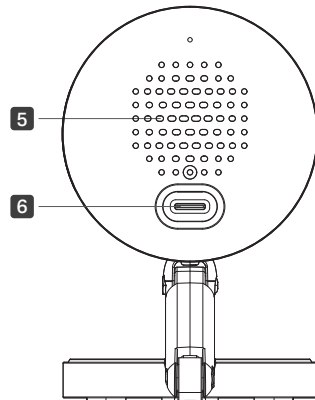

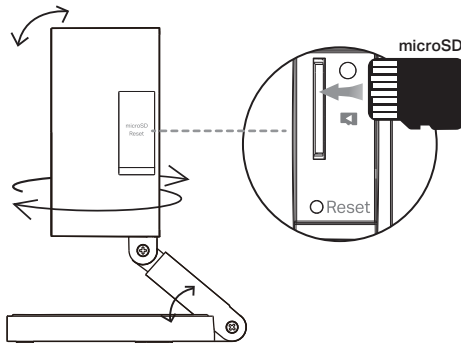
- 1 System LED

Adjust View

Tilt and rotate the camera and stand for your desired viewing angle.

microSD Card Slot

Open the cover. Insert a microSD card (not included) and initialize it on the Tapo app for local recording.

Reset

Open the cover. Use a pin to press and hold for at least 5 seconds to reset the camera to factory default settings.
