1. Reference

3. MPE Calculation Method

Predication of MPE limit at a given distance

Equation from page 18 of OET Bulletin 65, Edition 97-01

$$S=PG/4\pi R^2$$

Where: S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

4. Result

As declared by the Applicant, the EUT is a wireless device used in a fix application, at least 20 cm from any body part of the user or nearby persons; from the maximum EUT RF output power, the minimum separation distance, $r=20\text{cm}$, as well as the gain of the used BT antenna is 2.6Bi and 2.4G antenna is 2.3dBi, the RF power density can be obtained.

5. simultaneous MPE Result

The sample support two modular, each module has its own antenna, so need consider simultaneous transmission;

According to KDB447498 D01 for Transmitters used in mobile exposure conditions for simultaneous transmission operations;

Σ of MPE ratios ≤ 1.0
