We need an attestation about these products explaining the difference between the 4420 and the 4440 and the differences between the XP501 and the XP601, since only the XP601 was tested.

Item	We need either a copy of the FCC DOC certificate for the XP501 and XP601 or a letter stating that they were FCC verified.
Resolution	An attestation letter was received declaring that the printers have been FCC verified to Class A Emission limits.
