2.1. TEST MANNER

- The EUT has been associated with personal computer and peripherals pursuant to ANSI C63.4-1992 and configuration operated in a manner which tended to maximize its emission characteristics in a typical application.
- The DELL keyboard, COMPAL monitor, HP printer, PRIMAX mouse and ACEEX modem were connected to the GIGA-BYTE PC.
- The 15-PIN D-TYPE cable and BNC cable were tested in order to find the maximum emissions. Since the 15-PIN cable generates the worst case, the mode was used as the final data.
- d. The following display resolution were investigated during the compliance test:

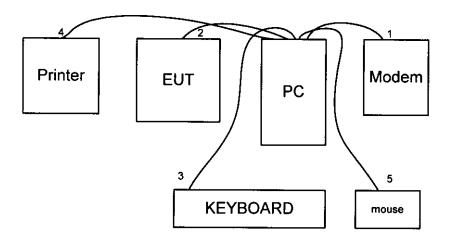

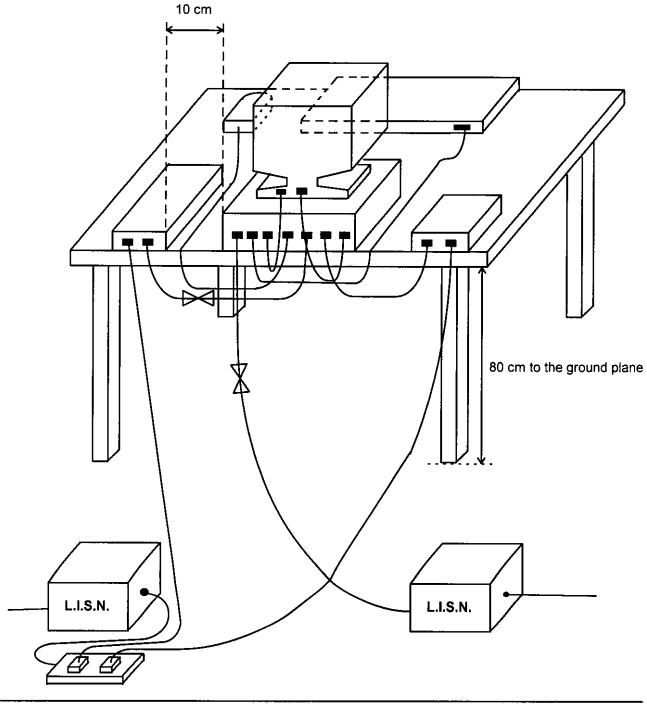

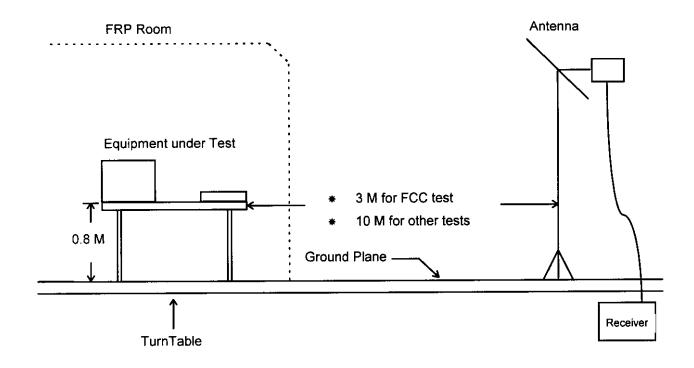
