

## 4 Test Standards and Limits

### 4.1 FCC Radiofrequency radiation exposure limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$[(\text{max power of channel})/(\text{min test separation distance})] \cdot \sqrt{f(\text{GHz})} \leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm
- The result is rounded to one decimal place for comparison
- 3.0 and 7.5 are referred to as the numeric thresholds

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm, and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm according to 4.1 f) is applied to determine SAR test exclusion.

For 2.4G band device, the limit of worse case is

$$P_{\text{max}} \leq 3.0 \cdot D_{\text{min}} / \sqrt{f} = 3.0 \cdot 5 / \sqrt{2.480} = 9.525 \text{mW}$$

### 5.2 RF Exposure Calculation

The Max Conducted Peak Output Power is 2.10mW. The best case gain of the antenna is 0dBi.

0dBi logarithmic terms convert to numeric result is nearly 1

According to the formula. calculate the EIRP test result:

$$EIRP= P \times G = 2.1 \text{ mW} \times 1 = 2.1\text{mW} < 9.525\text{mW}$$

So the SAR report is not required.
