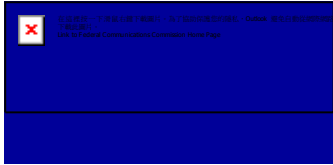

PRE-APPROVAL GUIDANCE PROCEDURE

## I. INTRODUCTION

In establishing the requirements for Telecommunications Certification Bodies (TCBs), the Commission allowed TCBs to certify equipment; however, certain equipment authorization functions continue to require oversight by the Commission. Section 2.964 specifies Pre-Approval Guidance (PAG) procedures for continuing the Commission oversight where compliance review procedures are not fully developed.<sup>1</sup> The PAG procedure permits the equipment authorization approval process for certain types of applications where there is no existing Commission guidance, where the Commission has only issued partial guidance, or where Commission oversight of the approval process is still considered necessary, for example, for nascent technologies.

The PAG procedure for TCBs applies to finalizing the equipment authorization approval for devices identified in the PAG List
