First steps:

- Insert micro SIM card into the slot;
- After inserting the SIM card close the SIM port lid. Do not remove the card while the device is powered on;
- Connect the device to the power source;
- Open network connections on your PC and search for MikroTik wireless network - connect to it;
- The configuration has to be done through the wireless network using a web browser or mobile app. Alternatively, you can use a WinBox configuration tool <http://mt.lv/winbox>;
- Open <http://192.168.88.1> in your web browser to start configuration, user name: *admin* and there is no password by default;
- Click the (Check for updates) button and update your RouterOS software to the latest version, must have a valid SIM card inserted;
- Choose your country, to apply country regulation settings;
- Set up your wireless network password;
- Set up your router password;
