


CARRY LOOP Conveniently carry your REEVUS anywhere using the magnetic phone mount which doubles as a carry loop.





1. If you can't find your Bottle, enable Lost Mode. This will trigger Find My App notifications when your Bottle is nearby. 2. Tap "Continue".


3. Follow the on-screen steps to finish setting up Lost Mode.




This device can be reset if you have trouble pairing the detachable LOC8 Finder with your iPhone, or if you want to unpair it and give it to someone else.
