

LED LIGHT BULB INSTRUCTION

CAUTION:

- 1.The product is self-ballasted lamp, suitable for use in damp locations.
- 2.The LED lamps are not suitable for use with dimmers.
- 3.This device is not intended for use with emergency exits
- 4.They are not intended for use in totally enclosed lighting fixture.
- 5.Assure that the fixture can support the added weight of the lamp/bulb.
- 6.Turn off power before inspection, installation, or removal.
