# **Product Description for Equipment under Test (EUT)**

The Hytera Communications Corporation Limited's product, model number: E-pack100 VHF (FCC ID: YAMEPACK100VHF) in this report is a Digital WANET Repeater, which was measured approximately: 295 mm (L) x 187 mm (W) x 68 mm(H), rated input voltage: DC 14.8V for battery.

## **Objective**



# Cellular Band (Part 22H) 26 dB Emissions & 99% Occupied Bandwidth for GSM (GMSK) Mode





The resolution bandwidth of the spectrum analyzer was set at 100kHz for below 1GHz and 1MHz for above 1GHz. Sufficient scans were taken to show any out of band emissions up to 10<sup>th</sup> harmonic.




# 30 MHz – 1 GHz (GSM Mode)

# 1 GHz – 10 GHz (GSM Mode)







# 1 GHz – 2 GHz (GSM Mode)



The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.







# Cellular Band, Right Band Edge for GSM (GMSK) Mode







## **Test Procedure**

Frequency Stability vs. Temperature: The equipment under test was connected to an external AC/DC power supply and the RF output was connected to communication test set via feed-through attenuators. The EUT was placed inside the temperature chamber. The power cable and RF output cable exited the chamber through an opening made for the purpose.

After the temperature stabilized for approximately 20 minutes, the frequency output was recorded from the communication test set.

Frequency Stability vs. Voltage: For hand carried, battery powered equipment; reduce primary supply voltage to the battery operating end point which shall be specified by the manufacturer.
