


## 1. WLAN Basic Test

# 1.1 Components

- -Windows 10 or above
- -Install ModusToolBox 2.3.1 or above (optional)
- -Download MFG app to the EVB (the Azurewave MFG app is stored in the EVB by default)
- -Make sure the DUT is in **CMSIS-DAP Bulk** mode (Amber Status LED ON). If the DUT is not in **CMSIS-DAP Bulk** mode (Amber Status LED ON), short push SW3 button to cycle through the **CMSIS-DAP Bulk** and **DAPlink** (Amber Status LED Ramping with 2Hz rate) mode.






External main antenna connector

AW-CU544-P / AW-CU544-E Top View






# 1.2 Using the Application

The following steps describe how to use the manufacturing test application.

- 1. Ensure that the Evaluation board is connected to the PC and loaded with the manufacturing test application, then press the reset button.
- 2. Using Windows Device Manager, look in the section "Ports (COM & LPT)" and note the COM port in use by the EVB (e.g. COM63).





- 3. Open a command prompt and navigate to the directory which contain the wl tool (e.g. d:\mfgtest\)
- 4. Verify that the application is working by entering the following command at the command prompt (where 63 corresponds to the COM port number of the DUT). d:\mfgtest\wl43438A1.exe --serial 63 ver

A list of available commands is displayed using the command: wl43438A1.exe --serial 63 cmds

Detailed help is available by entering the command: wl43438A1.exe --serial 63 -h



# 1.3 Example Commands

- 1. From the **Start** menu, select **Run**.
- 2. Type cmd, then click OK.
- 3. Navigate to the directory that contains wl43438A1.exe
- **4.** Enter **wl43438A1.exe --serial %1 ver** command to check the current WL driver version (%1 is the com port number).
- 5. Run the following command set:

This will send continuous Tx Packets with 300 us packet interval, 1000 byte packet length. Data rate =1Mbps, Channel=1 and output power =16dBm.

- \*\*.The default MAC address is 001122334455. Packets sent from Signal Generator must have the same MAC address as the DUT's MAC address (Runtime mac address can be overrode by using wl cur\_etheraddr xx:xx:xx:xx:xx:xx:xx.
- W. Use "wl counters" and find the received frame numbers in "rxdfrmocast".
- $\Re$ . The RX PER = [ (Total lost packets at the receiver) / (Total sent packets from the Signal Generator) ] x 100%.

Thus, PER =100% - [(**rxdfrmocast** numbers after sequence play) – (**rxdfrmocast** numbers before sequence play)] / (Total sent packets from the signal Generator) x 100%.




## 2.Bluetooth Basic Test

# 2.1 Components

- -bluetool 1.8.9.3 or later
- -Windows 10 or above
- -Install ModusToolBox 2.3.1 or above (optional)
- -Download MFG app to the EVB (the Azurewave MFG app is stored in the EVB by default)
- -Make sure the DUT is in **CMSIS-DAP Bulk** mode (Amber Status LED ON). If the DUT is not in **CMSIS-DAP Bulk** mode (Amber Status LED ON), short push SW3 button to cycle through the **CMSIS-DAP Bulk** and **DAPlink** (Amber Status LED Ramping with 2Hz rate) mode.






External main antenna connector

AW-CU544-P / AW-CU544-E Top View






#### 2.2 RF Performance Test

The following procedure explains how to configure the AW-CU544-P and AW-CU544-E for Bluetooth BR/EDR RF loopback testing using Broadcom BlueTool. At the completion of the procedure, connect the Bluetooth test instrument to the AW-CU544-P and AW-CU544-E with RF cable and performs the RF tests.




- 1. Start Broadcom BlueTool.
- 2. On the View menu, click Log Windows Details.
- 3. On the **Transport** menu, click **HCI Control**.



- 4. In Select HCI Control Window Transport:
- a. Select **UART** as the type of transport.
- b. In the COM port list, select com63. (check the port number in device manager)





- c. In the Baud list, type 115200.
- d. Do not select the CTS flow control and SLIP/Three-wire check box.
- e. Click OK.

# **5. RESETTING THE USB DEVICE**

To reset the USB device

•In HCI Control, in the HCI Control commands list, select 7.3: Host Controller & Baseband Commands (3 key), and then double-click Reset.

# **6. READING THE BLUETOOTH DEVICE ADDRESS**



#### To read the Bluetooth Device Address

 In HCl Control, in the HCl Control commands list, select 7.4: Informational Parameters (4 key), and then double-click
 Read\_BD\_ADDR.

The Bluetooth Device Address (BD\_ADDR) is displayed in the log window. The Bluetooth Device Address might be needed by the Bluetooth tester

#### 7. SETTING THE EVENT FILTER TO AUTOMATICALLY ALLOW CONNECTION

## To set the event filter to automatically allow connection

1. In HCI Control, in the HCI Control commands list, select 7.3: Host Controller & Baseband Commands (3 key), and

then double-click Set Event Filter.

- 2. In HCI Command: Set\_Event\_Filter:
- a. In the Filter Type list, select Connection Setup.
- b. In the Connection\_Setup\_Filter\_Condition\_Type list, select Allow Connections from all devices.
- c. In the Auto\_Accept\_Flag list, select Do Auto accept the connection with role switch disabled.

# 8. ENABLING WRITE SCAN

#### To enable Write Scan

1. In HCI Control, in the HCI Control commands list, select 7.3: Host Controller & Baseband Commands (3 key), and

then double-click Write\_Scan\_Enable.

2. In HCI Command: Write\_Scan\_Enable, in the Scan\_Enable list, select Inquiry and Page Scan enabled.



# 9. ENABLING TEST MODE

#### To enable Test Mode

• In HCI Control, in the HCI Control commands list, select **7.6: Testing Commands (6 key)**, and then double-click

Enable\_Device\_Under\_Test\_Mode.


The AW-CU544-P and AW-CU544-E are now ready to receive a connection request from the Bluetooth tester and begin testing specified RF parameters.



# 3. Device Provisioning

# 3.1 Components

- -Windows 10 or above
- -Install ModusToolBox 2.3.1 or above (required)
- -Make sure the DUT is in **DAPlink** mode (Amber Status LED Ramping with 2Hz rate). Short push SW3 button to cycle through the **CMSIS-DAP Bulk** (Amber Status LED ON) and **DAPlink** mode.





#### 3.2 Provision the Device

Use the following command to provision the device (path can vary depending on how the ModusToolbox is installed):
