2.2 MPE Calculation Formula

 $Pd = (Pout*G) / (4*pi*r^2)$

where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

2.3 Classification

The antenna of this product, under normal use condition, is at least 22 cm away from the body of the user. So, this device is classified as **Mobile Device**.

Note:

- 1. Determining compliance based on the results of the compliance measurement, not taking into account measurement instrumentation uncertainty.
- 2. 2.4GHz: The directional gain = $10 \log[(10^{G0/20} + 10^{G1/20})^2 / 2] = 6.41dBi$
- 3. 5GHz: The directional gain = 3.8 dBi + 10log(2) = 6.81 dBi

Conclusion:

The formula of calculated the MPE is: CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1

CPD = Calculation power density

LPD = Limit of power density

WLAN 2.4GHz + WLAN 5GHz = 0.30777 / 1 + 0.5851 / 1 = 0.89287

Therefore the maximum calculations of above situations are less than the "1" limit.
