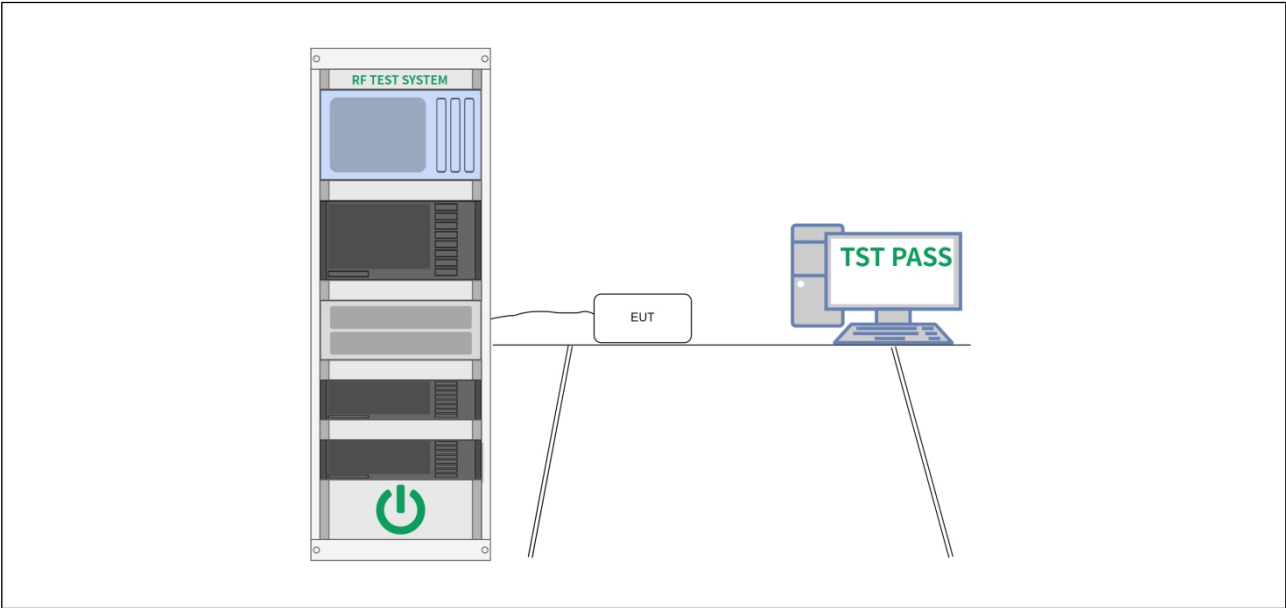
#### 4. 20dB Bandwidth
