# 7.0 RF POWER MEASUREMENTS

### **RF Power Measurements:**

Testing is performed per KDB 971168 D01 and across the transmit dynamic range of 37dBm/MHz to 27dBm/MHz for 20MHz Bandwidth.

The UUT was configured in the 16-User Beam Configuration (1CC) such that all ports were transmitting at the same output power level. The 64 ports of the UUT are the same design and pretesting showed that the power levels between sampling of various ports is the same. As all 64 ports are identical in design and equivalent power levels, the PSD was measured and the total MIMO Conducted Power was calculated for 64 ports. The MIMO EIRP was calculated with adding the antenna gain, 16 Beam reduction, and BF Gain to the conducted power level.
