2.8 Label and compliance information

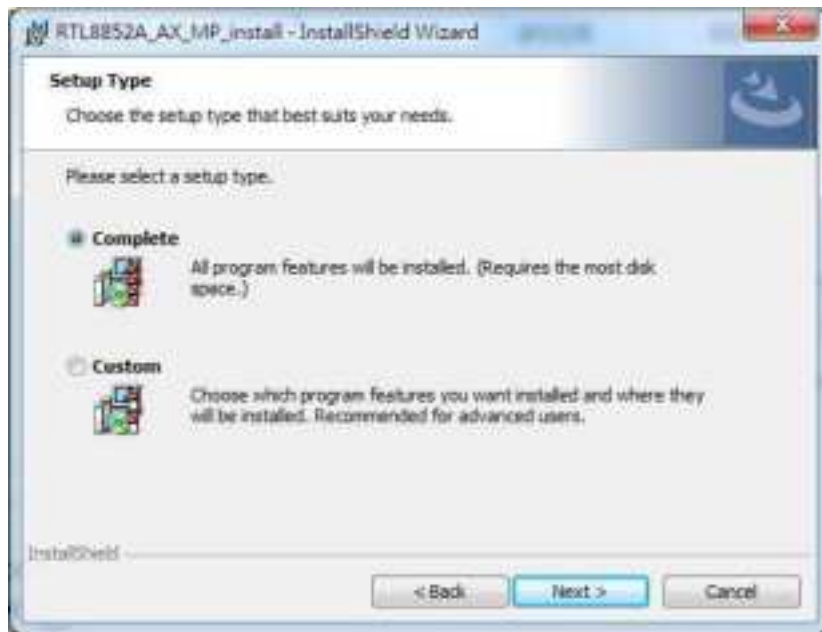
