I have reviewed the above referenced TCB application and find that the following item needs to be addressed before the review can be completed:

We have received communication from the FCC regarding your SAR measurements for CDMA2000 per the current FCC policies. The Output Power by Radio Configuration document indicates that SAR testing was performed using Radio Configuration RC4 with Service Option SO9. According to a preliminary guide for CDMA2000 provided by the FCC:

"For systems with P\_REV equal to 6 or higher, the service option described by 3GPP2 C.S0013 shall use service option number 55 and is called Service Option 55. The multiplex option in use can be either 0x01 or 0x02 depending upon the RC configured based on Table below."

Multiplex Option in use for Service Option 55:

Multiplex Option in use	Forward Fundamental Channel RC	Reverse Fundamental Channel RC
0x01	1, 3, 4, 6, or 7	1, 3, or 5
0x02	2, 5, 8, or 9	2, 4, or 6

Please provide SAR compliance measurement at the worst case measurement location using SO55. If the measurements differ significantly from the original measurements using SO9, please provide complete SAR compliance using SO55.

The RF block diagram (in both the Block Diagram and the Operational Description Exhibits) has formatting errors. Please submit an RF Block Diagram that has the text with no formatting errors.

Please note that if the max SAR values change from what was reported in the original application, several exhibits would need to be updated to correct the max SAR values reported (such as Users Manual).

The items indicated above must be submitted before processing can continue on the above referenced application. Failure to provide the requested information within 30 days of the original e-mail date may result in application dismissal and forfeiture of the filing fee. Also, please note that partial responses increase processing time and should not be submitted.
