In the power on state, long press the MFB button for 5 seconds, the red light is on for 2 seconds, and the system will sound at the same time,</div></div><div><div>Pairing</div><div>In the power off state, long press the MFB button for 3 seconds, the white light flashes slowly, and the system will sound at the same time. For new device connection, turn on the Bluetooth in your device and choose "Monster Mission 100" from the Bluetooth list to connect. After successful pairing, the white light keep on for 1 second and turn off.</div></div></div>	<div><div>Music</div><div>Play/pause: short press the MFB button Next song: music status, long press the “-” button for 2 seconds Previous song: music status, long press the “+” button for 2 seconds</div></div> <div><div>Volume Control</div><div>Turn down the volume: connected phone status, press the “-” button Turn up the volume: connected phone status, press the “+” button</div></div> <div><div>Call</div><div>Answer/hang up: short press the MFB button Reject the call: long press the MFB button for 2 seconds Cancel a call: when the caller does not answer, press the MFB button</div></div> <div><div>Voice Assistant</div><div>Connected phone status, press the MFB button twice</div></div>	<div><div>Reset</div><div>When the headset is on and not connected, press the MFB button five times quickly to clear the pairing record between the headset and the mobile phone and enter the device search pairing mode. If the new device is not connected within 3 minutes, it will automatically shut down</div></div> <div><div>Low Current Alarm</div><div>The red light flashes slowly, and the Bluetooth headset icon in the phone's status bar turns red</div></div> <div><div>Low Power Shutdown</div><div>The red light is on for 2 seconds</div></div> <div><div>Responsible for your hearing</div><div>To avoid hearing loss, turn down the volume of the music player before wearing headset.
